Judging Criteria for Food:

- Judging for food is divided into two (2) categories- Entrée and Dessert. You may submit one item in the Entrée category, and/or one item in the Dessert category.
- Items entered for judging **MUST** be items that your restaurant sells at Taste of the Town and are listed on your marquee.
- Judging is conducted on a "Blind Tasting" basis. The judging panel will consist of individuals with an excellent culinary background.
- TOT representatives will begin picking up food items at 4 PM. These individuals will not be identified to ensure that the food items are the same as what is being served to the general public.
- The Criteria for judging is as follows:
 - 10 points for taste
 - 10 points for presentation
 - 10 points for creativity
- All judging should be completed by 6:30 PM, and the winners will be announced at 7 PM.
- Awards will be given for 1st Place, 2nd Place, and 3rd Place in both the Entrée and Dessert categories.
- Award winners will be featured on www.TOTMB.com and several media venues.

People's Choice Awards:

- People's Choice Awards will be given for People's Choice Favorite Restaurant, Kid's Choice Favorite Restaurant.
- These awards are determined by a random polling of the general public who attends Taste of the Town.
- Award winners will be featured on www.TOTMB.com and several media venues.

Judging Criteria for Booths:

- Judging for booths is divided into two (2) categories- Small Booth and Large Booth.
- Awards will be given for 1st Place, 2nd Place, and 3rd Place in both categories.
- The Criteria for judging is as follows:
 - 10 points for labor involved
 - 10 points for creativity and development of theme
 - 10 points for best use of space
- Award winners will be featured on www.TOTMB.com and several media venues.

Winners will be announced at 7 PM on Center Stage.

When food items are presented to the Judges, the items will be described *exactly* the way the Description(s) are written on this Judging Application. Descriptions of winning Entrees/Desserts will also be provided to the media and will be featured on www.TOTMB.com, the Taste of the Town website.

Taste of the Town uses a "Blind Tasting" judging system, so the Judges do not know which food items come from which Restaurants. Also, when the Restaurants begin selling their food items at the event, they will not know if the customer buying the food is a TOT representative for Judging or simply an attendee of the event.

NOTE: Absolutely no Entrée/Dessert may exceed 4 Food Tickets. Please include # Food Tickets required for all food items on your booth's Menu Board/Marquee. 1 Food Ticket = \$1.00
